1. CALL TO ORDER/PRESENTATION TO THE FLAG: Mayor Anderson called the meeting to order at 6:00 p.m. He noted the meeting was for the purpose of presenting the proposed city budget for 2026.

4. PUBLIC HEARINGS:

Mayor Anderson opened the public hearing at 6:00 p.m.

Jeff Breckel commented on the budget details, and noted inclusion of trend lines would be helpful. He asked why categories with zero budget amounts were included. He also observed where personnel costs were not associated with site positions. He suggested changes to make it a more friendly and useful budget.

Mayor Anderson closed the public hearing at 6:04 p.m.

Ray Broughton, Stevenson Fire Chief provided information on the work being done on the transition between the city and the rural fire districts. He commended the work of the EMS staff in helping with the accounting details for the budget.

Ann Leuders, Skamania County EMS Superintendent, also provided details on that budget. She noted the city and the fire district each sharing a portion of costs in the past made it difficult to use any budget history as a guide, but future budgets will be based on

current operations. She provided information on the cost splits within the interlocal agreement. Both **Leuders** and **Broughton** noted as the city moves away from overseeing fire department operations costs will change.
