LOCATION: 968 SW Rock Creek DR, Tax Lot 02-07-01-0-0-1302-00

PROPOSAL: “To construct 19 cabins that will serve as nightly and weekly lodging, as well as an event space to be used for private weddings, reunions, and parties. On-site parking, public pedestrian access, landscaping, and enhancements to the riverbank will also be provided. Additionally, a plat vacation is proposed to provide a more cohesive property under one ownership group”.

PERMITS/STUDIES: This proposal requires approval from the Planning Commission as a Shoreline Substantial Development Permit. Permits from state and federal agencies may also be required. The application includes reports related to habitat and geologic hazards, and stormwater.

PUBLIC COMMENT: Any person may comment on this application. Written comment may be submitted at any time. All comments received prior to 5:00 pm on Dec 8 will be included within the packet for consideration prior to the meeting. Additional comment and verbal testimony will also be considered at the public hearing.

ONGOING INVOLVEMENT: Any person may request to receive notice of future hearings, copies of the decision once made, and appeal the decision.
