The group was surveyed in meeting 1 about Success Indicators for this Committee.

Discussion - See page 4 for the group's individual responses. An attempt to synthesize the input is represented below. There was no consensus on #1 due to a lack of ability to define "equitable/exorbitant."

1. Infrastructure Improvement and Expansion: Success ensures equitable sharing of financial impacts that do not burden residents with exorbitant costs when transitioning from septic to sewer and extending sewer lines while supporting small private development.

2. Informed Decision-Making: Success means that the committee sufficiently understands the scope of the issue and various financing solutions, builds trust in the decision-making process, and recommends middle-ground positions that are determined legal.

3. Inclusivity and Community Perspectives: Success entails considering all perspectives on the impacts of potential changes to the sewer ordinance and refraining from making decisions that benefit single perspectives or individuals. Success is improving trust by ensuring the committee understands the process, is supported to generate ideas to address sewer issues, and people feel heard and their time is valued. without consensus

Dinner Discussion:

Member sat at the table that represented their level of agreement with the following statement and discussed the various perspectives:

Assuming an equitable funding structure that does not burden residents with exorbitant costs or hinder small private development, I think sewer mainlines should be extended to City Limits by 2040, and a plan should be developed and implemented to maximize the number of parcels connected to the City Sewer System.

- Ratepayer should pay for most
 - Some openness to having developers or owners of vacant land pay for something
 - Think about 300 ft as a trigger
 - South Bend 150 ft to property line for new development
- Aggressive city led projects to extend are preferred
 - Penalties for "ready to serve" should be considered
 - Use carrots to convert people
- Maximize pursuit of grant funding
- Minimize cost of design and construction to the extent possible

- Developers (of vacant land) pays for all
 - No zone/location as trigger
 - Even single homes?
- Existing homeowners on septic system
 - Low income should be subsidized as much as possible
 - Waive SDCs
 - Grants CDBG, HEALing scars, USDA
 - Direct Legislature Request
 - Failure should pay for some (50/50?)
 - If system is operational, ratepayers should pay for all

Consider establishing a debt cap for each Development agreement:

- 2. Offer to waive SDC for people who have functioning septics and a new sewer line to hook up within a XXX period of time.
